This conference focuses on an in-depth update on the care of patients with Herpes Simplex and Varicella Zoster viral corneal disease. Topics will include the use of antivirals and steroids in viral keratitis, considerations before operating on patients with a history of viral disease, medications in the pipeline for treatment, and the long term management of sequelae including antiviral prophylaxis, neurotrophic keratitis, neovascularization, and corneal neuralgia after viral keratitis. Lectures will be focused and directed with opportunity for panel discussion to incorporate audience questions.

- 1 Discuss important new advances in the etiologies, diagnosis, and treatment/prevention of eye diseases.
- 2 Identify basic and clinical vision research that can be transformed into improved clinical care.

- 5 Identify clinical, scientific, and ethical issues confronting the profession.
- 6 Obtain information and tools through multiple facets to help ophthalmologists deliver high and efficient quality of care.
